- 5. A member from the Handicapped Student Association, Mr. Jim Hayes
- 6. A member from the Physical Plant, Mr. Howard Widmann
- 7. A member from the Fiscal Office, Mr. Barney Stanley

*8. A member from the Texas Vocational Rehabilitation Commission,

*9. A member from the Texas Commission for the Blind, Mr. Mike Evans

In capsule form, the committee would function as follows:

1. Texas Rehabilitation would be responsible for securing a list of mobility impaired students for the committee.

^{*}Because of a state regulation, these two people cannot be actual committee members, but they have agreed to be committee consultants in order to serve as resource persons.

- 2. After the class schedule is available, the mobility impaired students would be responsible for getting academic advisement and a tentative class schedule.
- 3. Two or three days prior to registration, the committee would meet with each student, go over his class schedule to see that it is physically feasible, give each student general information (handbook, maps, parking stickers), and take his assignment card and fees. At this point, the student is through with registration.
- 4. After meeting with the students, someone would be assigned to go through the first morning of registration and actually pull the cards according to the class assignment schedule which the students have turned in to the committee.

The purpose of the committee is to provide the mobility impaired students with both a general orientation to the campus and an early registration. Our aim is to make the transition to campus life more simple for handicapped students.
