#### National Association Of The Deaf Will Celebrate Its 100th Birthday

Cincinnati, Ohio will be the place to celebrate the 100th anniversary of NAD's existence June 29-July. 5, 1980. It is a once-in-a lifetime opportunity to participate in an event as great as that especially of the largest and oldest national organization of and by the deaf.

Most of the activities will be held in Stouffer's Hotel. Some of the events will be prepared by NAD, International Association of Parents of the Deaf, American Deafness and Rehabilitation Association, Junior NAD, and several other organizations which will provide more than 75 various activities, including workshops on Communication, Consumerism, Education, Legal, Rehabilitation, Sections (Education, Senior Citizens, Mental Health, SIGN, State Commission), Theatre, and Youth Related Programs.

#### Arkansas School For The Deaf Sued

William F. Eckstein, President of the Arkansas Association of the Deaf, filed a class action lawsuit against the Arkansas School for the Deaf on account of discrimination against hiring and promoting deaf employees at the school.

At this time insufficient information has been received pertaining to this case, but if the suit is successful, there is a possibility that it will be a landmark case for the nation. Then hundreds or even thousands of doors of opportunity will be quickly opened to countless deaf persons across the nation.

Hats off to Eckstein for his courage in leading the way in bringing deaf people out of the Dark Ages of oppression, prejudice and exploition. Does that sound familiar right here in Texas? When will we receive equal opportunity? When will there be upward mobility for deaf persons into administration of educational systems in this state?

#### Center For Deaf Opens In Fl Paso

El Paso's Center for the Deaf will move to a permanent location at 400 E. Robinson by May 1. City Council voted to buy a former sorority house for \$206,835 to house the deaf center.

Sara Siler, director, said the 10-year-old building is twice the size of current quarters at 1101 Birch and also has more off-street parking. Buses stop right in front of the building, too.

The one-story building will house a language lab, interpreter services, sign language classes, offices and a place to show captioned films on Saturday nights. With the new center, Ms. Siler said, she wants to expand a program to put more telecommunications network systems in businesses and homes of the deaf.

The center serves about 150 deaf persons each week. With the permanent location, the number could increase greatly.

# State Models For Screening Interpreters For The Deaf Workshop

#### 1-800-238-5544 Holiday Inn Offers Toll-Free TDD Reservation Service

The recent installation of a new C-Phone-1-A telecommunicator unit in the Memphis central reservation office of Holiday Inns Inc. is enabling those hearing-impaired persons with similar telecommunicator units throughout the U.S. to make reservations at Holiday Inn hotels.

The new service, first of its kind to be introduced by a major hotel chain, utilizes the advanced technology of Telecommunication Devices for the Deaf (TDDs), which a growing number of deaf persons have in their homes.

The TDD equipment consists of a cathode ray screen and keyboard unit. Typed messages are transmitted by the caller via a toll-free telephone line to a similar TDD unit at the Holiday Inn reservation center. A reservationist responds by typing a reply. The "conversation" is continued by the two parties on their keyboards and is visualized on the TDD screens.

The toll-free number established for this service is 800/238-5544. In Memphis, Tenn., the number is 794-4411.

"Until now, deaf persons had to ask friends to call and make reservations for them or take their chances on finding available hotel rooms," said Donna Nabors, administrator of reservations planning and control for Holiday Inns Inc. "Now they have the freedom and convenience of making reservations from their homes just as hearing persons do."

In the United States, more than 2 million people are deaf and another 14 million experience significant hearing impairment, Nabors said. Of these some 450,000 presently have access to TDD units, and that number is rapidly growing.

Recent legislation in California is paving the way for increased communications for hearing-impaired persons by providing TDDs for home use without charge, and more states are expected to do so in the near future.

Telephone toll charge reductions for TDD users, taking into account the increased time required to type and receive messages, have been approved in New York, Connecticut, Idaho and North Carolina. Similar legislation is under consideration in Maine, Wisconsin, New Jersey, Texas, North Carolina, Tennessee, Michigan, Maryland and California.

Holiday Inns Inc. is the largest non-government organization to provide special service for the deaf.

"The Holiday Inn System was a pioneer in making its hotels architecturally accessible to the wheelchair traveler, but until now we had no way of communicating with hearing-impaired persons," said Dick Hovermale, director of the Memphis reservation center. "Even with the current public interest in disabled citizens and their rights, the deaf population is often overlooked because theirs is an invisible handicap.

"This is the 100th anniversary year of the National Assn. for the Deaf, and 1981 has been designated by the United Nations as 'International Year of the Disabled Person.' The Holiday Inn System welcomes this opportunity to be able to do more to make travel easier for handicapped people."
