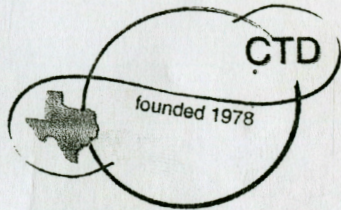

CTD: Relevant Background

Founded in 1978, CTD is a social and economic impact organization benefiting people with disabilities of all ages. Based on expertise developed as the oldest and largest consumer-led cross-disability organization in Texas, CTD provides quality services to businesses, organizations and individuals. CTD makes use of people with disabilities as subject matter experts; a unique perspective valued by our clients.

CTD has been deeply involved with HAVA and the Secretary of State since the debut of Texas' response to HAVA, including an appointment to serve on the state's HAVA Advisory Committee, input to the Secretary of State's Elections Division on the HAVA implementation plan, and development of a HAVA power point training tool for election workers and voters with disabilities that the SOS posted on their website.

CTD has completed numerous HAVA presentations, ranging from the Secretary of State's Annual Election Law Seminars in 2004, 2005 and 2006 to trainings to election workers and county judges and outreach presentations across the state to Texans with disabilities via CTD member organizations. We have conducted accessible voting machine demonstrations, typically getting the cooperation of the most significantly disabled person present to demo the machine.

CTD is recognized and sought out in the Texas State Capitol as an expert on voting issues for people with disabilities, providing analysis on three bills in the 79th Legislature and invited testimony to the House Elections Committee.

CTD is a recognized expert in training on effective interactions with people with disabilities with previous clients including corporate managers, district attorneys, poll workers and hotel reception personnel.

CTD has demonstrated experience in producing broadcast quality video and other media products. Two documentary films based on CTD public awareness projects have been released and shown in public screenings: "Shattering Stereotypes on Mt. Everest" (2004) and "350 Miles... 7 Days... By Hand!" (2005). In the last three years, CTD has won six local and statewide Media Awards for its public awareness projects.

CTD currently has 78 organizational members covering every region in the state. These member organizations represent over three million unduplicated Texans with disabilities and aging Texans.

Fees are established depending on the scope of work. All monies earned through fee-for-service consulting go to support the disability advocacy work of CTD, a 501(c) 3 non-profit.

Scope of Work

For purposes of meeting **HAVA Partners** goals to obtain quality HAVA on-line training materials, CTD proposes to produce:

- Post-produced video of approximately 5 minutes
 - 1) a person w/ disability talking about:
 - a. voting and what it means to them to be able to cast a private ballot.
 - b. a good voting experience at the polls.
 - 2) proper way to approach and interact with persons w/ various disabilities
 - 3) a few sample case studies -- two handled well, one handled poorly
- Also (text -- not video)
 1. 10 case studies.
 2. section on etiquette w/ 10 question test and correct answers and brief explanation
- Provide a letter of opinion on CTD letterhead on the CTD-produced training materials on appropriateness, sensitivity and compliance to current practices and regulations.
- Delivery date:

Compensation: **HAVA Partners** agrees to pay CTD as follows:

\$11,500 flat fee for services and deliverables described above. This is inclusive of CTD professional services and any expenses directly associated with performing the work. There will be an additional fee if additional services are requested.

Terms: \$5,750 due on contract execution, \$5,750 due upon delivery of products.
