## About This Booklet

The Governor's Committee on People with Disabilities, with the assistance of the Texas State Bar, Disability Issues Committee, offers this booklet describing Texas laws in 17 key issue areas. Laws in each of these areas are summarized in non-technical terms using a standardized format. The Committee decided to cover laws which impact more than one disability group, and/or which define an enforceable right or benefit rather than laws that establish services or describe general policy without enforcement mechanisms. The choices for the laws covered here were made in hopes of keeping this publication short enough to be useful.

Each issue area contains the following sections:

- **Texas Law:** describes provisions of Texas law that pertain to the issue
- **Texas Legal Citation:** describes statutory citations for the Texas laws
- **Contact:** provides names and phone numbers of Texas state agencies and/or local government with responsibilities for these laws
- **For More Information:** provides information regarding publications available from state agencies
- **Relevant Federal Laws:** lists selected federal laws and the agencies responsible for them
- **Local Ordinances:** describes the potential for local ordinances relevant to the issue

For the actual language and complete text of the Texas laws, please refer to the Texas Legal Citation section and then contact your local library or your state legislator. Contact the Governor's Committee if you have questions regarding laws affecting one particular disability group or laws establishing specific disability services.

The most far-reaching federal law that guarantees rights of people with disabilities is the Americans with Disabilities Act. For more detailed information about this law, contact the Governor's Committee. The Federal Rehabilitation Act of 1973 also guarantees rights of people with disabilities to federally funded programs. Ask your attorney if this law applies to your situation. Citations for federal laws are at the end of this publication.

This booklet is not intended to be an exhaustive analysis of Texas laws affecting people with disabilities. Although every effort has been made to be accurate, the authors do not warrant that the material contained herein is completely free of errors or will be completely accurate. Lawyers and others should verify important statements before relying on them.

# **Access to Information**

## **Texas Law**

Provides for accessible, available, and usable telecommunications services for people with disabilities. Requires state agencies to make available electronic public information. Requires electronic access to Texas legislative information. Provides for increased electronic access to library services. Provides for telephone interpreting services for people who can hear, and to speak with people who are deaf, deaf-blind, hard of hearing, or who have speech disabilities.

# **Assistance Dogs**

## **Texas Law**

Requires that people with disabilities who use assistance dogs be admitted to public facilities, be admitted on transportation carriers, and that they have full and equal access to housing accommodations. Extra compensation may not be required for such dogs, but the user is liable for any damages caused by the dog. To be recognized as assistance dogs, they must be trained by organizations generally recognized as reputable and competent by agencies involved in rehabilitation of people with disabilities. Offenses are punishable by fines of not less than \$300 and not more than \$1,000. Provisions are available for time off from work for state employees to attend training to receive an assistance dog.

# **Building Accessibility**

## **Texas Law**

Requires architectural accessibility of buildings and facilities and requires submission and approval of building plans and site inspections of:

- Government-funded buildings constructed or renovated after January 1, 1971
- State-leased buildings after January 1, 1972
- Privately-funded public accommodations built or renovated after January 1, 1991 (hotels/motels, restaurants, theaters, auditoriums, shopping centers, sales/rental establishments, transportation terminals, museums, parks, schools, day-care centers, and gyms)
- Privately-funded commercial buildings built or renovated after September 1, 1995

# **Compensation for Injured Workers**

## **Texas Law**

Provides for reimbursement of medical expenses and lost wages due to an injury on the job, or a work-related disease or illness. Benefits are available only if the employer has workers' compensation insurance or is self-insured. Some lost wages may be replaced if the work-related injury or illness causes the loss of some or all of the worker's wages for more than seven days. The injury or illness must be reported to the employer within 30 days. Various deadlines and restrictions apply.

# **Education**

## **Texas Law**

Provides for the free, appropriate *public education* of students with disabilities including assessment, services, procedures, and student/parent rights.

Law relating to *higher education* provides for accommodations and certain exemptions in required educational tests.

# Employment Protection

## Texas Law

Provides for protection against discrimination in employment based on disability when employers have 15 or more employees. For private employers, complaints must be filed with the appropriate administrative entity within 180 days after the alleged discrimination. Inquire about administrative requirements that may be relevant to your situation. Alternative dispute resolution is available.

# **Guardianship**

## **Texas Law**

Provides a legal system for assigning a guardian for people who are incapacitated. Each guardianship is tailor-made to provide only the specific assistance needed by such persons while preserving their rights and independence. The process has many legal requirements and can be expensive, complex, and slow. An attorney must file an application for guardianship with a probate court clerk to begin the legal process.

# Housing

## Texas Law

Provides protection against *housing discrimination* based on disability. Includes reasonable modification to common use areas as necessary for people with disabilities and changes in rules, policies, or practices to make housing usable by people with disabilities.

Requires a specified percentage of the units in publicly-funded, *multi-family housing* (apartments) built after 1969, to be accessible. The percentage of required units depends on the total number of living units available. No state requirements exist for privately-funded, multi- or single-family dwellings.

# Insurance

## Texas Law

Provides that an insurance company cannot deny or limit coverage, charge more for coverage, or refuse to renew a policy if the company is not able to prove that the person with a disability presents a higher risk. This risk must be established based on valid evidence and the company may not reject a person with a disability if the risk is no greater than that of other consumers they are willing to insure. Contact your company or insurance agent in writing and ask for reasons for policy or claim denials.

# Medical Directives

## Texas Law

Provides for designation of an individual to make health care decisions if a doctor certifies that an individual is unable to do so. Unless otherwise stated, such a "health care power of attorney" gives the authority to make any and all health care decisions in accordance with the individual's wishes. An agent may consent, refuse, withdraw, or withhold treatment including life-sustaining services. This health care power of attorney must be completed while the individual is able to make the needed decisions.

# **Protections for People with Mental Illness or Mental Retardation**

## **Texas Law**

Protections afforded people with *mental illness* include the right to learn of their rights, and the right to see the information in their medical records.

Provides for rights of people with *mental retardation* such as the right to participate in the development of an individualized treatment plan and the right to live in an environment which allows one to make as many decisions as possible.

## **Parking and Buying Gas**

### **Texas Law**

Provides that certain persons with disabilities, or persons who transport them, are eligible for disabled placards and/or license plates from the county tax collector. This identification entitles them to park at no charge in metered spaces, parking lots, and garages operated by certain governmental entities.

Time-limited placards are available to persons with temporary disabilities. People with disabilities from other states or countries with identification displaying the international access symbol are eligible for these parking privileges. Veterans with disabilities also have certain parking privileges, although to park free they must have a placard and/or license plate as described above.

The Texas placards or license plates also allow people with disabilities to receive fuel pumping services (refueling) for self-service prices at stations where both services are available.

# Property Tax Exemption

## Texas Law

Provides for property tax exemptions for people with disabilities who cannot gainfully work. Homeowners with disabilities who qualify can receive a \$10,000 exemption from school taxes in addition to the \$5,000 exemption for all homeowners. Veterans with disabilities may qualify for property tax (home or other property) ranging from \$1,500 to \$3,000 depending on the severity of the disability. Contact your local appraisal district after January 1 and before April 30.

# **Safety and Protection from Abuse or Neglect**

## **Texas Law**

Provides for the protection of people with disabilities from abuse, neglect or exploitation. Requires reporting by anyone suspecting such treatment. Mandates investigations of reports within 24 hours. If abuse, neglect, or exploitation is confirmed, services can be provided to increase the safety of the person with a disability.

# Sales Tax Exemptions

## Texas Law

Allows people with disabilities to purchase certain *items and services* tax free. Repair, maintenance, and/or modification of exempt items are also exempt. Examples of exempt items: equipment for producing braille or enlarging print; hearing aids and telecommunication devices for the deaf; wheelchairs; crutches; walkers; and support dogs, equipment, and food for them. To document that the sale is exempt from sales tax, the purchaser must give the seller a prescription or a tax exemption certificate available from the Texas Comptroller of Public Accounts.

*Vehicles* that are modified to be driven by, or to transport, people with orthopedic disabilities are exempt from the motor vehicles use and sales tax. *Modifications* made to vehicles to accommodate such persons are also exempt. To receive these exemptions, the purchaser must complete the Title Application Tax Affidavit Form, available from the Texas Comptroller of Public Accounts.

# **Transportation**

## **Texas Law**

Provides for the establishment and general operations of metropolitan and rural transit authorities. There are approximately seven urban and 42 rural transportation authorities and 300 public/private transportation providers. No state law provides for rights or access in this area; however, federal law does make access requirements.

# Voting

## Texas Law

Requires that *polling* places be free from any barriers that would keep a person with a disability from reaching the voting station. Provides for access to *precinct conventions*. Provides for assistance in reading the ballot and/or *voting*. Allows the use of language interpreters, including sign language *interpreters* for voters who cannot communicate in English. Provides for ballots to be brought to the curb, or polling place entrance, if the voter cannot enter. Provides a system for *early voting* by mail. Various deadlines and restrictions apply in the above provisions.

Voter registration is done through your county tax assessor/voter registrar, or with assistance from state human service agencies. You may also register to vote when obtaining or renewing your driver's license or ID card.


