Hello CTD campers:


Welcome to CTD's Building Unity Jamboree, our 22nd Annual Delegate Assembly. CTD would not have been the advocacy force it has been for the last 22 years without the hard work and dedication from you the members and especially from the staff.


CTD has faced many challenges and changes over the years, and we still have many challenges and changes facing us. The greatest threats to our rights are imminent. Several legal cases before the US courts are trying to whittle away our basic civil rights under the Americans with Disabilities Act (ADA). The fragmentation of different disability groups, each fighting for their own piece of the pie still results in a mess of crumbs. The Coalition of Texans With Disabilities is the only true cross-disability coalition and we must do better at working together to eliminate barriers to equal and full participation in life.

Texas' current leadership is not disability friendly. Governor Bush refused to give Texas support to us in the Olmstead case where the U.S. Supreme Court ultimately ruled that states must provide Medicaid funded services in the most integrated setting. And, as of today he has continued to refuse to take a position supporting the ADA in the Garrett case currently before the U.S. Supreme Court. The Texas Republican Party platform seeks to amend the ADA to exclude from its definition those persons with learning disabilities, infectious diseases, behavior disorders and substance addiction. The platform advocates for repealing the National Voter Registration Act, and opposes Internet voting that would facilitate Texans with disabilities basic right to cast a secret ballot. It is imperative we as members of this coalition work hard in our community to register all people with disabilities, and educate them about the issues facing people with disabilities. We will not be a powerful voice if we do not exercise our right to vote. You can register to vote and register your friends to vote until October 6 for the November 7 General Election.

Although we represent all Texans with disabilities, CTD currently has only 40 organizational members and very few of those organizations have bothered to attend the annual delegate assembly of their coalition. Every disability organization should be active members of the Coalition of Texans with Disabilities. We must unite to bring about real changes for equal rights and total inclusion in the lives for the 4 million Texans with disabilities.

This weekend is about building unity and building CTD. The activities we have planned for everyone will help us grow as individuals and as a cross-disability coalition. We will be building relationships, building knowledge, building unity, building confidence, and building leadership. So let's get going and start building!

- ◆ Unification of Individuals and Groups Representing Diverse Disabilities: Increase the representation of various disability populations and groups in the CTD organization, and increase the emphasis on common goals and interests for all persons with disabilities.




