CUTS AND COMBINATIONS

The 70th Legislative Session opened January 13th with much pomp and circumstance. The Governor's Inauguration was celebrated with bar-b-ques, balls, and art shows. While the parties and speeches create a festive atmosphere, critical problems lurk in the background waiting to be addressed.

An approximate one billion dollar deficit for 1987 and a projected deficit of \$3.8 billion for the next biennium leave Texans with a bleak financial picture. Since only two-thirds of the state budget is dedicated funds (i.e. funds committed for a specific purpose by law, the state constitution or log court order), unless drastic changes are made, the bulk of the cuts will come from the undedicated third. Since human service funding is almost all from the undedicated third, they are once again threatened. Governor Clements has proposed an across-the-board 26% cut in our undedicate funds and an increase for higher education. A one-quarter cut in funding will hit hard on vital services.

The other major threat to disability services is the various proposals to combine agencies. The most prominent of these is a proposal by Representative Mark Stiles of Beaumont to create a study to combine all Texas State Agencies into twenty-three state agencies. The Department of Human Services would include the current Department of Human Services, the Department of Mental Health and Mental Retardation, Texas Rehabilitation Commission, Texas Commission for the Blind, the Department on Aging, Commission on

Alcohol and Drug Abuse, Texas Commission for the Deaf, the Health and Human Services Coordinating Council, and the Cancer Council. The Texas Education Agency would be expanded to include the School for the Blind, the School for the Deaf, and the Teacher Retirement System and Optional Retirement, and the Foundation Schools. Similar combinations are proposed for all other disability agencies.

A very legitimate question is how and/or why oppose a study? But a closer look reveals several reasons. First, with such detailed "suggestions" regarding ways of combining, the agenda has already been set. Second, once the idea of combination is legitimized by such a study, more limited combinations such as those annually proposed for the disability agencies become more acceptable and more likely to happen. Finally, with little real evidence of cost cutting without cutting services, any combination during such economically hard times seems suspicious at best. Now is the time to get involved! Call your legislators!

YOU ARE THE KEY

You are the key to successful legislative advocacy! You may ask how you got such an awesome responsibility? Well, the reality is that legislators listen to people like you in their own districts a lot more than they do to many of the people who roam the halls of the Capitol in Austin.

You hear stories of major gloom and doom and wonder what difference you could possibly make! A big difference!

You don't need to be an expert on every subject that the legislature is addressing! You need to express what your need is in your own language. Many legislators never see a disabled person from their own district.

Disability services are abstract concepts that usually do not have a high priority. A visit from you can make these concepts become real. Let them know that real people receive services.

CTD has one-page issue papers on many subjects. If these would help, write or call us and we will send them to you.

Most legislators are in their own district on Fridays. It is a good time to set up a meeting.

A few easy steps to follow:

- Find out who your state representative and state senator is. (Call the League of Women Voters or your County Tax Assessor.
- 2) Get to know who runs the office.
 - 3) Call the office and set up a meeting tell them you want to talk about disability services.
 - 4) Go with someone else Power in numbers.
 - 5) Tell the legislator in your own words what you want if you have written material, bring it with you and leave it. (Again, CTD has issue papers available.)
 - 6) Ask them what their positions are on your concerns.
 - 7) Thank the legislator for his/her time.
 - 8) Visit or call the office to get updates on what the legislator is doing. His/her staff will be able to help you.
 - 9) Set up a second meeting with the legislator 30 days after the first meeting. Make them accountable!

You are important! The needs are great and we all have some responsibility.

- * Do you feel you are not getting the services you need from the Independent Living Center?


If you or someone you know are having any of the above problems, the Client Assistance Program (CAP) may be able to help. CAP can help any disabled person receive services from the Texas Rehabilitation Commission, the Texas Commission for the Blind, and Independent Living Centers. CAP can also advise service providers or anyone who has questions about vocational rehabilitation services.
