On Thursday September 10th the "Medicaid Home and Community Quality Services Act of 1987" S. 1673 was introduced by Senator John Chafee. A major press conference was held with groups representing mostly persons with developmental disabilities.

The focus of this legislation is to freeze the amount of Medicaid dollars used for institutional care and to redirect all new dollars to community placement. Letters from you and your organization asking for support of this bill will help enormously. Write to:

### TECHNOLOGY FOR DISABLED CHILDREN

The Technology to Educate Children with Handicaps, TECH, Act was introduced in Washington August 3rd. The TECH Act would provide 20 million assistance under the Education of the Handicapped Act to estabish Assistive Device Resource Centers for infants, toddlers, children and youth with disabilities. The centers would provide training to professionals, family members and handicapped students on topics related to use of assistive devices. In addition they would have the ability to develop and modify devices and provide follow up services to those who receive equipment.

Each state's Governor would establish the centers through an application process open to public and private non-profits. Each state would be required to provide a 20% state fund match.

The bill was introduced by Sen. John Kerry (MA), Weicker (CT) and Stafford (VT), and is intended both to help students reach their educational potential and to increase their interaction with their non-disabled peers.



### YUPPIE FUND RAISING IDEA!

Each purchase you make with your credit card could now benefit disability rights group, the American Foundation for the Blind. Ms. Hulsey is also the USPS liaison to the Architectural and Transportation Barriers Compliance Board.

# National Health Care Campaign

As you probably know, there is Catastrophic Helath Care Legislation and Employer Health Benefit Legislation being considered in Congress. To show our state Senators and Representatives there is a growing movement supporting health care reform, CTD has enclosed National Health Care Campaign Postcards in this newsletter. - \* Health Insurance in the benefit packages of all working families;

### TEA GOES FOR ACCESS GRANT

Texas Education Agency is applying for a federal grant to increase access to education for disabled children and provide employment to the general public. If TEA receives the Removal of Architectural Barriers to the Handicapped Grant, funds will be divided into subgrants to the Local Education Agencies (LEAs). TEA is applying for approximately \$2.6 million in funds to be divided into about 60 — 18 month projects.

There are two goals of the project are two fold. One is to provide financial assistance to the LEAs to: 
\* make available to disabled children the variety of education programs available to non-disabled children, 
\* provide accessible non-academic and extra cirricular activities for disabled children.

\* provide access for adult disabled persons involved in the education of disabled children or eligible to participate in the programs adminstered by the LEAs.

The second goal has to do with creating employment opportunities for the general public, particularly in areas of high unemployment, through the award of the subgrants and the projects they create.

The National Council on Independent Living (NCIL) has also written a strong letter of concern outlining the problems Commissioner Dart has had in running the Rehabilitation Services Administration. (RSA). NCIL is also concerned because several of Assistant Secretary Will's activities directly undermine the concept of consumer control in the independent living movement.

The issue is one of control generally. Is the Commissioner a token only to be rolled out for public display, or does he have the authority to run RSA as outlined in The Rehabilitation Act?
