TROUBLE IN RIVER CITY, TROUBLE ON THE HILL



A big controversy is brewing in rehabilitation services these days. Recently the Council of State Administrators of Vocational Rehabilitation, CSAVR, wrote the Secretary of the Federal Department of Education, William Bennett. Bennett is the boss of Madeleine Will, Assistant Secretary of Special Education and Rehabilitative Services. Will is the boss of Justin Dart Jr, the Commissioner of Rehabilitation Services Administration, RSA, which funds vocational rehabilitation services independent living services the Client Assistance Program and more.

The CSAVR letter outlined a number of deep concerns CSAVR has regarding Assistant Secretary Will's handling of RSA and the effects this is having on services to disabled persons. Areas of concern outlined in the CSAVR letter are: Will's taking away authority from the RSA Commissioner's position by blocking travel and personnel appointments, taking positions away from RSA and giving

them to other programs, assigning special education duties to regional RSA offices, providing incorrect information to Congress regarding rehabilitation services and not allowing the RSA Commissioner to testify to Congress. The letter charges the Assistant Secretary with responsibility for: a six year decline in rehabilitation positions at regional and federal levels, spending scarce rehabilitation resources on ill-conceived studies, delaying issuance of the Regulations for the 1986 Rehab Act Amendments and blocking implementation of the state Supported Employment Program.

The letter, signed by both TRC Commissioner Vernon (Max) Arrell and TCB Executive Director, Westbrook as well as 22 other state rehabilitation administrators, ends as it begins on a strong note..."It is a tale... indeed, an apparent effort to dismantle the Rehabilitation Services Administration."



DHS PUBLIC HEARINGS




BE A DISABILITY RIGHTS SUPPORTER!

Disabled Adult Education Conference

"Empowering the Adult with Special Learning Needs: A National Challenge" is the theme of the First National Congress for Adults with Special Learning Needs. The Congress will address adult and continuing education issues as they relate to policy, fiscal and program concerns. It will take a cross disability focus, looking at the needs of adults with disabilities including deaf and hearing impaired, blind and visually impaired; mentally ill and mentally retarded, mobility impaired, learning disabled and other disabilities which may interfere with the learning process.

The Congress will focus on identifying consumers, determining how they learn and what they want to learn, developing recommendations for effective programs and giving direction to providers. Proceedings from the Congress will be published and widely disseminated.

Over the past two years, CDS has provided residential services and supports to 80 people with disabilities, including many severe and multiple impairments. Jay Klein, Director of the Residential Support Program, believes that this program provides an alternative continuum-based model by providing supports in the community according to their level of need. than having individuals work their way up through a series service from "more settinas restrictive" to "less restrictive".
