# erspective

Disabled Texans took their first tentative steps into the political arena of the Lone Star State in February of 1978. A group of individuals concerned with the rights of and issues affecting disabled Texans met in Houston to discuss methods of addressing common concerns. During that first meeting a commitment was made to begin the work of developing a statewide coalition of organizations and individuals, and an interim board of directors was established to draft bylaws and plan the first delegate convention.

Seven months later disabled leaders from across Texas met in San Antonio (September 29) to convene CTD's initial delegate convention. During the convention: proposed bylaws were adopted; a platform of mutual concerns was developed; priorities and goals were set; and, officers and board members were elected.

The dream of a statewide coalition became reality in January of 1979 when CTD received its non-profit charter. In the ensuing years CTD has become the recognized state voice for expression of cross-disability concerns, in the public and private arena. CTD has been instrumental in providing information to both the public and private sectors and for four years provided aid to some 20 member organizations through the VISTA program.

In years past CTD has been the vital force in organizing and working in cooperation with other organizations to fight for the rights of disabled people to gain full access to all aspects of Texas society. Recently, the coalition was the spearhead in organizing a rally in Austin to voice concerns over the proposed cuts in funding for human services. CTD has become the voice in the State Legislature through which disability concerns are, and will be, expressed.

As our State is celebrating its Sesquicentennial this year, so too does CTD proudly come to 'Big D' to celebrate its 9th Annual Convention, and to renew its commitment to be THE voice for disability concerns for ALL disabled Texans and lead the way to an accessible future.

# resident's Messa

Welcome to Dallas and CTD's 9th Annual Convention. CTD is comprised of member organizations and individuals, like yourself, who are concerned about issues that are confronting persons with disabilities. We are here in Dallas this weekend to decide the direction CTD will take for the next year and to make plans for the future. Where are we going and how do we get there are questions a growing organization must always ask. CTD is growing and the growth has come about because of people like you. You have been involved in CTD and that involvement needs to continue. In fact, the time has come for your renewed activism.

Disabled people have made major strides toward independence over the last decade. These gains have not come easily. It has come about by individuals actively voicing their needs to those in power. We organized and because of this we experienced victories.

Architectural and communication accessibility is much more common. Support Services that enable disabled people to become independent are available. Many more disabled people are employed. A move toward more community based programs has begun.

Though there have been these gains we have only begun to achieve the equality that the disability rights and independent living movement promised. In fact, many programs and services are being threatened to be cut back or abolished. Rights that we thought we had are now being challenged by our highest court. The mood of the country has changed and we are being forced, slow as it may seem, back into the closets and institutions. At a time when unity and strength is so important, crossdisability coalitions are becoming harder to keep together because of competition for scarce resources and philosophical differences that are questioning the basic foundations of cross-disability coalitions

The theme of our convention "Using the Political System for Change" recognizes the need for CTD to become an even stronger political voice in Austin as well as organizing people at the grass-roots level. Our political power is not based on money but on people. We must recognize the potential of our own power before those in power will listen to us. Using the political system is one way to exert our power.



We are in Dallas to learn better to use our political system to bring about changes that will result in programs and services that promote independent living and disability rights. Working together we can. Enjoy the Convention.



# CTD Legislative Platform 1986-87

This platform was developed by the CTD Legislative Committee from resolutions of past conventions, further input from CTD member organizations and was approved by the CTD Board of Directors.

#### CTD PRIORITIES

#### APPROPRIATIONS ISSUES

Level IV funding (the highest level requested by the agency) for disability agencies including: Texas Rehabilitation Commission, Texas Commission for the Deaf, Texas Commission for the Blind, the Human Rights Commission, Texas Department of Human Resources, Department of Mental Health and Mental Retardation, Governor's Committee for Disabled Persons, Architectural Barriers Removal Office, State Library Services

for the Blind and Physically Handicapped, Crippled Children's Services and Independent Living Services.

Increased funding or the Architectural Barriers Removal Office to enable the office to investigate and enforce compliance with architectural access codes which are legislatively mandated.



#### CTD ALSO SUPPORTS

#### APPROPRIATIONS ISSUES

Establishment of a fund to pay for interpreters for the deaf during the legislative session.

Development of **four or more Centers for Independent Living** in areas not currently being served with independent living services.

Funding for adult abuse services to include shelter, counseling and respite care as well as investigation.

Inclusion of insurance antidiscrimination bill to ensure that insurance and tort reforms will not be made at the expense of people who become disabled at the fault of another party.

Adoption of statewide Respite Care bill which would provide services (through TDHS) to families which provide the majority of care to their disabled and elderly family members.

#### LEGISLATIVE ISSUES

Continuation as separate state disability agencies: Texas Rehabilitation Commission, Texas Commission for the Blind, Texas Commission for the Deaf, Texas School for the Blind and Texas School for the Deaf.

Inclusion of program accessibility in the Sunset Evaluation criteria, so that disabled persons are able to access services from state programs without architectural, communication and other barriers.

Adoption of a **Public transportation accessibility** bill to require that transit systems in the state of Texas must be accessible to all citizens, including Texans with disabilities.

Adoption of statewide attendant services bill which would formalize and expand the TDHS Shared Attendant Program Pilot Project adopted during the last session.

Increased scope of enforcement of architectural barriers legislation to cover public facilities not included in the act and to include counties with populations under 45,000.

#### LEGISLATIVE ISSUES

Prevention of Local Measured Service, LMS, telephone service, which would negatively impact many disabled persons who must rely heavily on their telephone to live independently in the community.

Improvement of coordination of genetic screening services provided by the state; present services are fragmented and uneven in quality.

Adoption of In Home and Family Support Bill which would provide a wide range of support services to families with members who are disabled and assist in mainstreaming them in the community.

Change of state weights for Special Education funds within the community public schools to emphasize more integrated placements.

Continuation and improvement of services to deaf-blind persons to assist them in achieving independence and involvement in their communities.


