



#### GOING PUBLIC WITH OUR ISSUES

The Health and Human Services Coordinating Council met Friday May 2nd to discuss combining and cutting services. It was clear at the meeting no one found the job easy. John Hanson, Director of the State-Federal Relations Office made a presentation on the Gramm-Rudman Hollings cuts relationship with state cuts. Basically his message was that cuts will be calculated in relation to states' August budgets. If Texas cuts before Gramm-Rudman is invoked (and this seems very likely) effects will be drastic for numan services.

Two possible dublications of services HHSCC dould find thus far were the Texas Rehabilitation Commission and the Commission for the Blind as well as the Texas School for the Blind and the Texas School for the Deaf.

The HHSCC will need a lot of consumer support to take the position that services should be maintained at their current level or that cuts should be minimal. Members of the HHSCC asked why no consumers were at the meeting. We in the disabled community talk among ourselves yet we do not go on and talk about our issues in public. We have agreed that we can take no more cuts but we must now go public. Your letters, visits and brone calls are needed now! At your organizational meeting give everyone paper, pen and envelopes and ask them to write the Committee and express their concerns about the need for maintaining services at least at their current level.

It is also important we show support for ways of increasing the states revenues. Let the candidates and public officials know the kinds of revenue enhancement you support (taxes, lottery, racing, whatever it may be).







The Department of Human Servicesd (DHS) is proposing to cut Community Care Services to Aged and Disabled persons. This is just the first salvo in the budget cutting battle. Vital services are being proposed to be cut, services that never were fully funded. There is no "fat" in numan services programs in Texas and their is no room for cuts.


We need all of you and the local groups in your area to write to the people listed below. We need to let the DHS Board and staff know we won't stand for any cuts. What people can write:

As you may recall from earlier issues of the CTD News: the Federal Legislature is considering Legislation called the Community and Family Living Amendments (CFLA) which would promote independent living for disabled who head support services to live in the Community. Specifically 5.8. 873 and HB 2902 would amend the Social Security Act so that funding which is presently only available for institutional programs would encourage the development and provision of community based alternatives for severely disabled persons. Enclosed in this newsletter is a petition to Senator Bentson snowing support for the CFLA Senate Bill. You are encouraged to get. as many signatures (with addresses) as possible to show the grass roots support for this legislation. With Federal and state cuts, in funding for services it is more important than ever that we let our representatives know we support community programs.

#### BITS AND PIECES

- \* Travis County has recently released at no charge a new Texas license plate for people eligible for handicapped parking. The plate does not legally replace the small license plate sticker or card for the dash board but has a large "handicapped symbol" printed on the plate for easy identification. Are these plates available in your area?
- \* Social Security has a toll free TDD number: 1-800 325-0778. The US Postal Service has produced a pamplet on the "Free Matter for the Billing and Handlicapped" mailing privelege, answering some of the most commonly asked questions. Copies are available from your post office.
- \* The National Association of the Deaf has appointed Gary W. Olsen as the new Executive Director of the 105 year old organization. Olsen, NAD's third E.D. has been acting director since Nov. 1984.
- \* The School of Allied Health Services, University of Texas Medical Branch, Galveston Island. Texas is sponsoring "A National Conference on Health Promotion for Persons with Disabilities" August 10-12, 1986 on Galveston, Island. The conference has been designed to increase the knowledge and skills of health professionals in the delivery of health promotion programs and services to persons with disabilities.
