Disability Conference

At the end of March, five HRA representatives attended a three-day conference in Dallas called "Understanding Texas Accessibility."

The conference, largely targeting businesses, building owners, architects and engineers, discussed enforcement of the Americans with Disabilities Act. This included panel discussions and presentations about issues in public barrier removal, differences between ADA and TAS; compliance responsibil-

ities of architects and building owners; new legislative efforts and HUD requirements for accessible residential and multi-family housing.

Board Member and Architect **Mike Love** served as moderator for several of the sessions on architectural design compliance. Mike is a registered planning reviewer and performs accessibility inspections for construction alterations.

Staff members **Dave Watson, Nellie Harrell, Jamie McCartney, and Terry Ridle** attended to promote HRA with a promotional booth for the duration of the conference. Mike Love provided booth space for HRA.

Speakers included John Hockenberry.

Correspondent on *Dateline NBC*; Kent Waldrep of the Kent Waldrep National Paralysis Foundation in Dallas and Marsha Mazz of the U.S. Architectural and Transportation Barriers Compliance Board. Also

Reeve's Daunting Challenge

viewpoint by **Tony Snow** of *Detroit News*.

Recently, helpers wheeled Christopher Reeve up a long ramp in a Washington hotel meeting room and then turned him deliberately and dramatically toward a throng of philanthropists. He squinted through the low-slung chandeliers, seemingly impassive, while the crowd rose to shower him with sustained applause.

His disability is an engrossing thing. Here is a guy crackling with vitality, an activist who erupts with passions and ideas, a performer who can summon laughter even as he wheezes out words and a director eager to take on a series of ambitious cinematic projects. He is all that and more - and he can't so much as scratch his nose.

Mr. Reeve was there to help the Parkinson's Action Network, which raises money to combat Parkinson's.

Mr. Reeve is getting impatient with talk of fate and inexorability. "In the next century," he predicts, "we will explore the frontiers of inner space." He argues that researchers have scratched and clawed their way to the verge of conquering diseases and injuries that not long ago seemed hopelessly catastrophic. He describes progress as if he were ordering a burger carry-out. All we need to do, he says,

is "pay for a cure."

He and longtime journalist Morton Kondracke and others have banded together in hopes of persuading Congress to mount a man-to-the-moon style effort to combat a long list of diseases and injuries and, through the liberal application of cash, produce "the cure to which we are all entitled."

When you think about it, he is reduced to banging a tin cup boldly. He and colleagues have finessed two key questions: Is government the only vehicle for salvation? What about hedging one's bet and cozying up with the world of commerce?

After all, government doesn't do customer service very well. Medical businesses, in contrast, make their money by producing cures for cash, along the lines Mr. Reeve suggested. That being the case, the self-described "disability community" might want to open a new front in the war against mortality. Make common cause with research firms or mutual funds that can direct substantial sums of money toward companies doing promising work.

One can't look at Mr. Reeve without hoping that researchers produce the miracles they seek. But one also hates to see them reduced to beggary before legislators who are more adept at cutting road construction deals than mulling over the mysteries of life.

For those, like Mr. Reeve, who refuse to become professional victims, the ultimate act of defiance may be to stop depending solely on Uncle Sam - who is a fickle partner at best - and start thinking about ways to befriend organizations whose survival depends on giving people what they actually want.

Bee Venom therapy for MS

The American Apitherapy Society now knows of 4,000 Americans who use bee venom to treat diseases, including MS, lupus, arthritis and chronic fatigue. Although the MS Association of America does not endorse the treatment, it gave a \$250,000 grant to Georgetown University to begin a study to determine if the venom is safe and nontoxic. There is some evidence that bee venom may work to stave off some of the effects of the disease, because its components affect both the neurological system and the immune system. 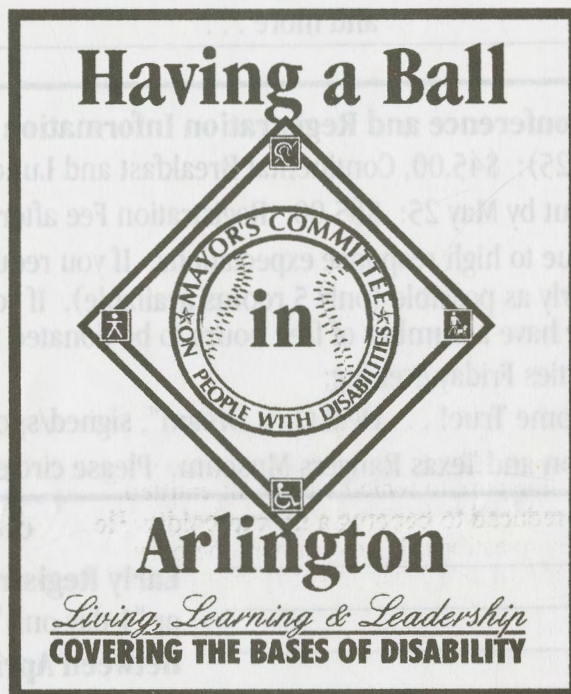
