TEXAS REHABILITATION COMMISSION GOALS FOR EMPLOYMENT OF THE HANDICAPPED IN STATE SERVICE

It is the policy of the State of Texas as expressed by the Governor to provide equal opportunity for employment, without discrimination, to the handicapped in all positions in which they can perform required job duties efficiently and safely.

The Texas Rehabilitation Commission has set up a program that develops employment opportunities for qualified handicapped persons within State agencies and encourages full consideration for employment and utilization of the handicapped in all State governmental positions.

Each State agency designates an official to serve as Coordinator for its headquarters office and field offices. These Coordinators have specific responsibility for assuring that handicapped applicants and employees receive full consideration in all matters pertaining to employment.

Employment of the handicapped is encouraged through the dissemination of informational and promotional material to State agencies relative to the selective placement of the handicapped. The Texas Rehabilitation Commission gives support to the program through training courses for Coordinators and other agency personnel. Technical advice and assistance are furnished as well. Liaison is constantly maintained with State agencies, Governor's Committee on Employment of the Handicapped, and private organizations concerned with the rehabilitation and employment of the handicapped.
