



Today June 10, 1936 I stood alone!

I stood right up for several seconds, then sat down abruptly, and after a few minutes of rest I tried it again. Just as I got on my feet my Mother came into the room. She squeaked in glee:

"O Daddy! The Baby's standing up!"

My Father came prancing in, proud as though he had done it himself.

Their excitement made me nervous, and I sat down again so suddenly it hurt.

I had to cry a little, but they both hugged me very tight and told me how wonderful I was, so I smiled at them and they went away to let me try again.





Today November 19, 1935 I have my first tooth!

I had been feeling cross for some weeks. My Mother told all her friends I was "teething." This meant nothing to me; I thought she was just excusing my ill temper. I never knew anything about teeth. I think it is stupid not to have brought them with me. I hear I will soon be getting a lot more. I hope they don't all hurt like this one.

The second tooth came December 2, 1935

The third tooth came December 31, 1935

The fourth tooth came January 16, 1936
The fifth tooth came January 17, 1936

At eleven months Shirley Sue had 12 teeth

Today August 8, 1936 ^{when began walking} I took my first step (Had taken
^{a few steps along began} ~~this~~)

I have been creeping and crawling for
some time but today I grew tired of
these slow methods of getting about,
and decided to walk. It was easier
than I had thought and I wish I
had dared to try sooner. I fell
down, of course, but I got up quick-
ly and took another step right off.





Today _____ I had my first Party.

A lot of other Babies came with their Mothers who were all quite interested in us until things to eat were served. The Mothers had a pretty table filled with good things to eat but we only had milk and little white crackers. As it was my party, this didn't seem right and some of the Babies cried about it.

The party lasted most all the afternoon and by the time they left I felt pretty tired and Mother said I must have a nap.

Today, December 25, 1935 is my "first Christmas."

I have a lovely big Christmas tree all covered with pretty things. They tell me that last night was Christmas Eve and that Santa Claus trimmed the tree. I just stared and stared.

I didn't see Santa Claus but he came down the chimney and brought lots of new toys. He filled my stockings which Mother says she hung over the mantelpiece.





Today May 30, 1936 is my Birthday!

That means that it is a year ago today that I came down from the stars. How long a time it seems! It is as though I had always been here with my Mother and my Father. They seem to grow sweeter to me each day.

IT SEEKS TO ME

*That if my meals are regular
And my formula is right
And if I get my orange juice
And lots of sleep at night,*

Due to the loss of Shirley
Doris Baby book, I am recording
the dates of her illness in this little
book given by the Hospital as a
future record.

In July ¹⁹³⁶ when she was seventeen
months old she took the measles. Having
been exposed to Larry who had just
preceded her — case was light.

Norman, Larry, Shirley Sue and I left
on Tues July 13-1937 for Memphis, Tenn. for
purpose of consulting with Dr. Willis Campbell
concerning back ^{& shoulder} condition. (we had been to
see him in March 1936 when she was ten
months old). After seeing the dr. on Wed. morning
we left for St. Louis that afternoon for
purpose of consulting with Dr. V. P. Blair concern-
ing malformation right ear. Enroute she
was taking sick suddenly a few miles from
Cape Girardeau, Mo. Contracted sick in
~~Hospital~~ ^{Hotel} there till Saturday morning when
we moved her to hospital on recommendation
of Dr. Hall who we had called in on Thursday
evening. She seemed to be suffering from
sore throat, weakness of back, nose and
severe constipation, fever running around
103 & 104. On Sunday was clear of fever and
was dismissed by Dr. Hall, but due to
weakness of Shirley we decided to wait till
Monday before leaving for St. Louis. ^{Early} Monday
~~morning~~ ^{afternoon} late we noticed she had no
use of her left arm — condition was reported
to nurse on floor but she was unable to
contact Dr. Hall till around 6 P.M. — He

pronounced the case as Infantile Paralysis
of left arm. and isolated her, allowing me to remain with
her, Norman & Larry returning home the
following day. We remained isolated till
June. Early 27 when we left by private car
to St. Louis where we were met by Norman,
who had compartment on train ready for us —
arrived in Alberta at 8 A.M. Wed. July 28-1937.
After arriving home consulted Dr. Granville
who put her in brace latter part of August
which she wore till last of Nov. or first of Dec.
Consulted Dr. W.B. Carroll of Dallas last Dec.
On Jan. 2 he put on brace to hold arm out of place
muscles at rest. We stayed one week in Dallas going
to clinic each day to learn exercises. This brace she
wore till July when a stronger brace was made but of some
style — wore this till Oct. 17-1938 — due to condition
of back Dr. Carroll thought advisable to remove brace.
Took exercises till Nov. 1939 when went to Warm
Springs, Ga. where Dr. [unclear], chief surgeon, said
exercises had done all good they could. Consulted
on the foundation from Mon. to Thurs where
was also sick in infirmary with upset stomach.
Had chicken pox in Dec. 1940, taking germ from Larry
who had it in Nov. — Operated on in Baylor Hospital —
Dallas on Friday, June 7, 1940 by Dr. Carroll
for lowering of right scapula and lessening
tension of neck muscles on rt. side. Remained in
Hospital till June 16 (Sunday). Was very low
following operation — operation was at A.M.
out of operating room at A.M. — immediately
put under oxygen & given glucose and saline
water — blood transfusion on Sat. morning
and more glucose — Dr. Moore fed
called in Sat. afternoon — more glucose on
Sunday — conscious for 1st time on Sunday and
improvement began which increased rapidly
during week. Wore backbraces six weeks removing
them on July 19-1940. In Oct. 1940 discovered made
by Dr. Carroll that back was worse & exercises for back started
